DIAGNOSIS: GUDGEON BEARING REPLACED ON SERVICE CALL AND WENT OUT AGAIN AFTER A VERY SHORT TIME.

SERVICE QUOTE: QUOTED PARTS AND LABOR OF 4706.85 TO SHANE AND HE APPROVED QUOTE

SERVICE PERFORMED: GUDGEON CAP BEARINGS- REMOVED CENTER DRINE LINE (U-JOINTS BAD), USED JACKS TO SUPPORT HINGE TO REMOVE GUDGEON CAP. REMOVED RETAINING BOLTS AND INSTALLED ADAPTER TO REMOVE GUDGEON CAP. TRIED TO REMOVE GUDGEON CAP. STARTED TO MOVE AND SEIZED UP AND WILL NOT MOVE ANY FARTHER. TRIED TO USE CRANE TO GET CAP TO MOVE BUT STILL WILL NOT MOVE. HAD OUTSIDE WELDER COME IN AND CUT CAP OFF GUDGEON PIVOT PIN. CLEANED THREADS AND MADE SURE GUDGEON CAP WILL SCREW ALL THE WAY INSIDE. INSTALLED NEW BEARINGS, SNAP RINGS AND SEAL IN GUDGEON CAP AND GREASED BEARINGS WITH PT507. INSTALLED GUDGEON CAP AND TORQUED TO SPECS. INSTALLED RETAINING BOLTS AND TORQUED TO SPECS. REPLACED U-JOINTS AND INSTALLED CENTER DRIVE SHAFT. INSTALLED ZERT AND PLUGS IN CAP AND GREASED.

PIVOT PIN BEARINGS-WHEN GUDGEON CAP WAS BEING CUT OUT, FRONT BEARING RACE AND BEARINGS WERE NICKED. PUT PRESSURE AGAINST TIRES AND HIT BEARING TO REMOVE FROM PIN AND BEARING FELL OUT ALONG WITH REAR PIVOT PIN BEARINGS. CAGE IS COMPLETELY GONE FROM REAR BEARINGS. SEAL WAS COMPLETELY WORN AWAY. DRAINED REAR AXLE AND DISCONNECTED HYDRAULIC LINES TO REAR AXLE AND SCV'S. REMOVED ELECTRICAL WIRING HARNESS FOR LIGHTS AND SEVEN PIN CONNECTOR. REMOVED BRACKETS AND FED LINES AND WIRING BACK THROUGH GUDGEON. SUPPORTED FRONT OF GUDGEON WITH STANE AND USED CRANE FOR REAR FRAME AND ROLLED APART. SUPPORTED REAR FRAME ON A JACK STAND. CLEANED SURFACES ON BEARING JOURNALS. HEATED INNER BEARING RACE AND REMOVED BEARING. CLEANED JOURNAL WHERE OLD BEARING WAS AND SURFACES FOR SEALS. REMOVED FRONT AND REAR BEARING CUPS AND INSTALLED NEW CUPS. INSTALLED NEW REAR BEARING AND SEAL, GREASED BEARING. INSTALLED V-SEAL AND ROLLED BACK TOGETHER. ALIGNED PIN AND INSTALLED BEARING SEAL AND NEW FRONT BEARING, GREASED.

REAR DRIVE SHAFT-WHEN GUDGEON CAP WAS OFF FOUND THAT JOURNAL WHERE BEARING SET AND SEALING SURFACE FOR SEAL ARE DAMAGED FROM WHEN BEARING WENT OUT AND SCARED BOTH SURFACES. REMOVED DRAW BAR SUPPORT AND SCV'S AS A UNIT. CLEANED OFF REAR FRAME OF DIRT TO ACCESS REAR AXLE BOLTS. REMOVED COVER TO GET TO BOLTS. CLEANED OUT CAVITY WHERE BOLT HEADS ARE LOCATED. PUT SOCKET ON BOLTS AND THEY ARE SO RUSTED THAT THE SOCKET JUST SPINS ON THEM. USED SMALLER SOCKET AND BEAT SOCKET ONTO HEADS TO GET THEM OUT. RAISED REAR FRAME OFF REAR DIFFERENTIAL AND ROLLED DIFFERENTIAL AND DRIVE SHAFT OUT AS ASSEMBLY. REMOVED DRIVE SHAFT AND FOUND THAT SHAFT IS BENT ABOUT 2 INCHES BEHIND BEARING JOURNAL. PINION SEAL ON REAR DIFFERENTIAL IS LEAKING. REMOVED YOKE AND FOUND YOKE TO BE GROOVED. REMOVED SEAL AND CLEANED SURFACES AND INSTALLED NEW SEAL AND YOKE. TAPPED HOLES IN AXLE HOUSING FOR NEW BOLTS AND WASHERS. INSTALLED DRIVE SHAFT INTO PIVOT PIN

AND ROLLED REAR DIFFERENTIAL BACK UNDER REAR FRAME. INSTALLED BOLTS AND TORQUED. INSTALLED DRAW BAR SUPPORT AND WHILE TIGHTENING BOLTS RIGHT SIDE NUT WELDS BROKE ON NUT AND WHERE NUT IS CAN NOT GET WRENCH THERE TO HOLD NUT TO FINISH TIGHTENING BOLT. USED TORCH AND CUT BOLT OUT OF FRAME. INSTALLED NEW BOLT, WASHER AND NUT. TIGHTENED BOLT. RAN HYDRAULIC AND ELECTRICAL THROUGH GUDGEON AND RECONNECTED CONNECTIONS.

Service Performed:

Gudgeon Cap bearings:

Removed center drive line(u-joints are bad), used jacks to support hinge to remove gudgeon cap, removed retaining bolts and installed adapter to remove gudgeon cap. Tried to remove gudgeon cap started to move and seized up and will not move any farther tried to use crane to get cap to move but still will not move, had outside welder come in and cut cap off gudgeon pivot pin. Cleaned threads and made sure gudgeon cap will screw all the way inside. Installed new bearings, snap rings and seals in new gudgeon cap and greased bearings with PT507. Installed gudgeon cap and torqued to specs, installed retaining bolts and torqued to specs, replaced u-joints and installed center drive shaft. Installed zert and plugs in cap and greased.

Pivot pin bearings:

When gudgeon cap was being cut out front bearing race and bearings were nicked, put pressure against tires and hit bearing to remove from pin and bearing fell out along with rear pivot pin bearings, cage is completely gone from rear bearings, seal has completely worn away. Drained rear axle and disconnected hydraulic lines to rear axle, and SCV's, removed electrical wiring harness for lights and seven pin connector, removed brackets and fed lines and wiring back trough gudgeon. Supported front of gudgeon with stand, used crane for rear frame and rolled apart. Supported rear frame on a jack stand. Cleaned surfaces on bearing journals, heated inner bearing race and removed bearing. Cleaned journal where old bearing was and surfaces for seals. Removed front and rear bearing cups and installed new cups. Installed new rear bearing and seal, greased bearing, installed V-seal and rolled back together. Aligned pin and installed bearing seal and new front bearing, greased.

Rear drive shaft:

When gudgeon cap was off found that journal where bearing set and sealing surface for seal are damaged from when bearing went out and scared both surfaces. Removed draw bar support and SCV's as a unit, Cleaned off rear frame of dirt to access rear axle bolts. Removed cover to get to bolts, cleaned out cavity where bolt heads are located. Put socket on bolts and they are so rusted away that the socket just spins on them. Used smaller socket and heat socket onto heads to get them out. Reaped rear

rusted away that the socket just spins on them, used smaller socket and beat socket onto heads to get them out. Raised rear frame off rear differential and rolled differential and drive shaft out as assembly. Removed drive shaft and found that shaft is bent about 2 inches behind bearing journal. Pinion seal on rear differential is leaking, removed yoke and found yoke to be groove, removed seal and cleaned surfaces and installed new seal and yoke. Tapped holes in axle housing for new bolts and washers. Installed drive shaft into pivot pin and rolled rear differential back under rear frame. Installed bolts and torqued. Installed draw bar support and while tightening bolts right side nut welds broke on nut and where nut is can not get wrench there to hold nut to finish tightening bolt. Used torch and cut bolt out of frame. Installed new bolt washer and nut, tightened bolt. Ran hydraulic and

DIAGNOSIS:JACKED UP HINGE AND FOUND PINS ARE WORN WITH A LOT OF MOVEMENT. STEERING CYLINDERS MOVED STEERING WHEEL AND WATCHED CYLINDERS AND CYLINDERS MOVED AT BARREL END OF CYLINDERS.

SERVICE QUOTE: QUOTED SHANE PARTS AND LABOR OF 2970.88 AND HE APPROVED QUOTED AMOUNT.

SERVICE PERFORMED: STEERING CYLINDERS-DISCONNECTED HYDRAULIC LINES AND CAPPED. REMOVED PIN RETAINERS. LEFT REAR BOLT SNAPPED OFF FLUSH WITH TOP OF WASHER. REMOVED FRONT PINS AND REAR PINS HAD TO USE TORCH AND HIT EARS TO GET PINS TO COME OUT. REMOVED CYLINDERS AND FOUND THAT BARREL END OF CYLINDERS BUSHING IS GONE AND HOLE IS EGG SHAPED. SENT CYLINDERS TO BE RECLAIMED. CLEANED ALL HOLES AND CHECKED PINS TO ENSURE THEY SLIDE THROUGH HOLES EASILY. SPENT A FEW HOURS TRYING TO GET BOLT OUT OF GUDGEON FRAME. CAN NOT DRILL DUE TO WHERE BOLT HOLE IS LOCATED. GROUND ENOUGH TO GET STUD INTO HOLE AND WELDED INTO PLACE. INSTALLED NEW BUSHING INTO CYLINDERS AND INSTALLED ON TRACTOR. INSTALLED NEW PIN SEALS AND CYLINDER PINS DUE TO THE ORIGINAL PINS BEING WORN (LIPPED). CONNECTED HYDRAULIC LINES.

HINGE PINS-WITH HYDRAULIC LINE, MIDDLE DRIVE SHAFT AND ELECTRICAL REMOVED, SUPPORTED FRONT HALF OF TRACTOR AND USED CRANE ON REAR HALF OF TRACTOR. REMOVED SNAP RING AND RETAINING BOLT AND WASHER. ADJUSTED HINGE ENOUGH TO PUSH TOP PIN OUT OF HINGE. LOWER HINGE PIN WILL NOT COME OUT. WILL TURN BUT NOT COME OUT. USED LONG PRY BAR AND BOUNCED TRACTOR UP AND DOWN UNTIL PIN MOVED OUT OF HOLE. ROLLED HALVES APART AND FOUND THAT LOWER FRONT FRAME HOLE IS BALY WORN AND LIPPED. HOLE NEEDS TO BE BUILT UP AND GROUND OUT ENOUGH FOR PIN TO FIT SNUGLY IN HOLE. REMOVED OLD BUSHING AND INSTALLED NEW BUSHINGS. AFTER HOLE REPAIR WAS FINISHED, ROLLED HALVES BACK TOGETHER AND INSTALLED TOP PIN WITH WASHER AND RETAINING WASHER AND BOLT. INSTALLED SHIM PACKS IN LOWER SECTION OF HINGE AND ADJUSTED TO GET LEVEL (YOKE TO YOKE) INSTALLED LOWER PIN AND SNAP RING. INSTALLED ZERT AND PLUGS IN PINS AND GREASED. RAISED HINGE TO ENSURE NO MOVEMENT WAS FOUND-CHECKED GOOD.

front pins and rear pins had to use torch and hit ears to get pins to come out. Removed cylinders and found that barrel end of cylinders bushing is gone and hole is egg shaped. Sent cylinders in to be reclaimed. Cleaned all holes and checked pins to ensure they slide through holes easily. Spent a few hours trying to get bolt out of gudgeon frame, can not drill due to where bolt hole is located, ground enough to get stud into hole and welded into place. Installed new bushing into cylinders and installed on tractor. Installed new pin seals and cylinder pins due to the original pins being worn(lipped). Connected hydraulic lines.

Hinge pins:

With hydraulic line, middle drive shaft and electrical removed, supported front half of tractor and used crane on rear half of tractor, removed snap ring and retaining bolt and washer. Adjusted hinge enough to push top pin out of hinge. Lower hinge pin will not come out, will turn but not come out. Used long pry bar and bounced tractor up and down until pin moved out of hole. Rolled halves apart and found that lower front frame hole is badly worn and lipped. Hole needs to be built up and ground out enough for pin to fit snugly in hole. Removed old bushing and installed new bushings. After hole repair was finished, rolled halves back together and installed top pin with washer and retaining washer and bolt. Installed shim packs in lower section of hinge and adjusted to get level(yoke to yoke). Installed lower pin and snap ring, installed zert and plugs in pins and greased. Raised hinge to ensure no movement was found –
